# SUMMER INFORMATION AND POLICIES

## TUITION/PAYMENT

- All summer payments are due in full the first day of classes/camps. We accept cash, check all credit cards.
- Our summer classes run for 6 weeks and our camps are a week (5 days). We do not prorate for any sick/missed days.
- If you sign up for more than one class or camp (siblings included) you will receive 15% off each additional class.

## TUITION BREAKDOWN:

## ILLNESS/SICKNESS

As a courtesy to other students, families, & our staff, students who are ill **should not** be in class. Students will not be permitted into the studio with a temperature of 100 degrees or higher.
